## Terms of Reference 2022

### Statement

The Australian College of Neonatal Nurses Inc (ACNN) is dedicated to the promotion of excellence in the care of neonates and their families. Its Special Interest Groups (SIGs) support this by monitoring, informing and making recommendations to the National Executive Committee. The focus of the Low Resource Countries (LRC) SIG is on supporting improved outcomes for small and sick newborns around the time of birth and throughout the neonatal period.

### **Purpose**

Our purpose is to partner with individual health care workers, government and non- government organisations in neighbouring low resource countries, to develop self-sustaining communities of health workers and village health volunteers (VHVs). We use low dose, high frequency training and train the trainer programmes, underpinned by the <a href="Helping Babies Survive">Helping Babies Survive</a> initiative, the Helping Babies Breathe and Essential Care for Every Baby programs. On a global level we hold a commitment to maternal and newborn health demonstrated through The Every Newborn Action Plan, Sustainable Development Goals, Global Strategy for Women's and the Children's and Adolescent' Health and Global Financing Facility.

## **Operating Committee**

The operating committee is to consist of at least 5 members including a Chair/Co-chairs, Secretary, Treasurer Liaison, Social Media Liaison and Ordinary Members.

Committee members hold positions for a period of 12 months which are vacated at the SIG annual meeting. A call for committee members will be made prior to the annual meeting and current committee members can renominate and any member can nominate at this time or at the meeting. Any ACNN member can attend the committee meetings throughout the year as an observer and elect to join as an ordinary member of the committee after attending three committee meetings (outside of the annual general meeting).

#### Meetings

- Bimonthly meetings will be held via videoconference on the 2<sup>nd</sup> Monday in February, April, June, August, October, December; commencing at 6.30pm AEST/AEDT
- Two of the bimonthly meetings will be open member meetings with a presentation
- The annual general meeting will preferably be held during the National Conference, but if not possible, it will be held via videoconference between September and December.

## Strategic Planning and Sustainable Committee Document

The LRC SIG creates actions that are documented under the umbrella of the current ACNN Strategic Plan and reports on these within the annual report. The LRC SIG Strategic Plan is available in Members Section on the website under the LRC SIG pages.

The LRC SIG will endeavour to meet the requirements of the Sustainable Committees Document (Policy 13), including having a member attend each national forum meeting and submitting a newsletter item 4 times per year.
