Amy and Jane will discuss at next ACNN open exec meeting</li> <li>STABLE program</li> <li>Discussed the program and not likely to be able to attend training in US for some time ie 2021 or even 2022</li> <li>Previous discussion: importance of NNP SIG bringing something extra to the table for the benefit of not only NNP SIG members, but importantly also for general neonatal nurse membership. Flagged that although the proposal for the workshop was unable to be supported due to significant costs, the alternative strategy would be to support the NNP SIG to fund some of the committee to attend the facilitators workshop.
